A complete high efficiency urinal system including qualifying 0.125 gpf fixtures AND valves must be installed to be eligible for a rebate.** Rebates are not to exceed purchase price.

## Commercial Application Form

### Program Instructions, Limitations and Terms

#### Devices must be installed prior to submitting application

1. The rebate amounts listed are applicable only to **WaterSense®** labeled high-efficiency urinal fixtures and valves **which operate at 0.125 gallons per flush (gpf). A complete high efficiency urinal system including qualifying 0.125 gpf fixtures AND valves must be installed to be eligible for a rebate. Urinals being replaced must use 1.0 gpf or more in order to qualify for the \$300 rebate.**
2. A rebate of \$300 will be issued for qualifying urinal fixture and valve systems. Rebate amounts are not to exceed purchase price of qualifying products.
3. New construction is eligible for a \$100 rebate per qualifying **WaterSense®** urinal fixture and valve.
4. Tenants must submit an owner-authorized letter.
5. Only urinals connected to the City of Bozeman public water supply are eligible for rebates.
6. Old urinal valves and fixtures can not be reused. Applicants agree to destroy or disable their old urinal fixture(s) and valve(s).
7. Installation of urinal fixture(s) and valve(s) is the sole responsibility of Applicant.
8. The urinal fixture(s) and valve(s) must be installed at the installation address listed.
9. A copy of the sales receipt is to be attached to this application. Receipts must include the make and model of the urinal fixture(s) and valve(s) purchased. The model number of the purchased urinal fixture(s) and valve(s) must match exactly the **WaterSense®** list to qualify for a rebate.
10. The effective date of the Bozeman Urinal Rebate Program is January 1, 2016. Rebates for urinal fixture(s) and valve(s) purchased prior to January 1, 2016 will not be given.
11. Applications will be processed in the order they are received.
12. Incomplete applications could be denied and returned to Applicant or result in a delay of the approval of the rebate.
13. Limited funding is available to issue rebates. Rebates will be issued on a first-come, first served basis through June 30, 2020. The City cannot guarantee that submittal of a rebate application will result in issuance of a rebate check. The Bozeman Urinal Rebate Program is subject to change or cancellation without notice.
14. A rebate check will be mailed within thirty (30) days of receipt provided the application is complete and funding is available.
15. A 1099 Tax Form is required of any parties that have been issued a total rebate amount equal to, or in excess, of \$600 by the City of Bozeman within one tax year.

#### Important! Please read carefully:

1. Proof of installation must accompany this application. Proof may take the form of an invoice from a certified plumber. Applications without proof of installation will not be considered for a rebate.
2. The City reserves the right to do an on-site inspection to verify installation of the urinal fixture(s) and valve(s) rebated through this program. Access to the rebated urinal fixture(s) and valve(s) must be provided at the time of inspection. If urinal installations cannot be verified, the payee will reimburse the City for the rebate funds received.
3. The City may contact Applicant by phone or in writing to verify information provided for in the application and/or to schedule an inspection. Any inspection shall occur during regular business hours.

#### Disclaimer

The City makes no representation or warranty regarding the urinal fixtures and valves eligible for rebate under the Bozeman Urinal Rebate Program. By participating in the program you waive and release the City from any and all claims and causes of action arising out of the purchase, installation, or use of the urinal fixture(s) and valve(s) purchased in connection with the rebate program. Any claim you may have based upon any defect or failure of performance of a urinal fixture or valve you purchased should be pursued with the manufacturer/distributor. City verification inspections are not a certification, warranty, or other approval with respect to the Applicant's compliance with applicable laws, ordinances and building codes.
